SECTION 2 Hazards identification

2.1 Classification of the substance or mixture

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

If overheated, aerosol cans can deform, explode and be propelled considerable distances. Put a protective helmet on before approaching the fire. Do not breathe combustion products.

5.3. Advice for firefighters.

GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health.

Always wear full fire prevention gear.

SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS

Normal fire fighting clothing i.e. fire kit (BS EN 469), gloves (BS EN 659) and boots (HO specification A29 and A30) in combination with self-contained open circuit positive pressure compressed air breathing apparatus (BS EN 137).

SECTION 6. Accidental release measures.

6.1. Personal precautions, protective equipment and emergency procedures.

Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. Send away individuals who are not suitably equipped. Wear protective gloves / protective clothing / eye protection / face protection.

6.2. Environmental precautions.

6.3. Methods and material for containment and cleaning up.

Use inert absorbent material to soak up leaked product. Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

SECTION 7. Handling and storage.

7.1. Precautions for safe handling.

Avoid bunching of electrostatic charges. Do not spray on flames or incandescent bodies. Vapours may catch fire and an explosion may occur; vapour accumulation is therefore to be avoided by leaving windows and doors open and ensuring good cross ventilation. Do not eat, drink or smoke during use. Do not breathe spray.

7.2. Conditions for safe storage, including any incompatibilities.

Store in a place where adequate ventilation is ensured, away from direct sunlight at a temperature below 50°C, away from any combustion sources.

HAND PROTECTION

Protect hands with category I (ref. Directive 89/686/EEC and standard EN 374) work gloves, such as those in latex, PVC or equivalent. The following should be considered when choosing work glove material: degradation, breakage times and permeation. Work glove resistance to preparations should be checked before use, as it can be unpredictable. Gloves' limit depends on the duration of exposure.

EYE PROTECTION

Use of protective airtight goggles (ref. standard EN 166) recommended.

SKIN PROTECTION

Wear category I professional long-sleeved overalls and safety footwear (ref. Directive 89/686/CEE and standard EN 344). Wash body with soap and water after removing overalls.

RESPIRATORY PROTECTION

If the threshold value (if available) for one or more of the substances present in the preparation for daily exposure in the workplace or to a fraction established by the company's prevention and protection service is exceeded, wear an FFP3 (ref. standard .. 141/EN 143) type half mask. The use of respiratory tract protection equipment, such as masks like that indicated above, is necessary to reduce worker exposure in the absence of technical measures. The protection provided by masks is in any case limited. If the substance in question is odourless or its olfactory threshold is higher than the relative exposure limit and in the event of an emergency, or when exposure levels are unknown or the concentration of oxygen in the workplace is less than 17% volume, wear self-ontained, open-circuit compressed air breathing apparatus (ref. standard EN 137) or fresh air hose breathing apparatus for use with full face mask, half mask or mouthpiece (ref. standard EN 138).
